### **Statement of Community Based Groups On the House Passage of Farm Bill**

On behalf of the undersigned, we express our outrage at the failure to provide for food security and to include significant farm safety net reform in the Farm Bill that was passed today in the U.S. House of Representatives. We urge that the final Farm Bill that emerges from the House-Senate conference reflect a full and fair Farm Bill. It must include farm, food and nutrition programs, and provide long-term protection and continued funding for the now-stranded but critical subset of programs and offices charged with serving the most chronically under-served segments of agriculture and our rural and urban communities. The House should immediately appoint conferees and work toward adoption of a final full and fair Farm Bill yet this summer.

The final bill should include all Titles as in the Senate bill, including a Nutrition Title; rejecting deep cuts or radical changes to the Supplemental Nutrition Assistance Program (SNAP) and SNAP-Education programs that currently help over 47 million Americans. In addition, the inclusion of reforms to further reduce spending on crop insurance and commodity programs is essential. Completion of action on this important and long-delayed legislation should also include robust provisions to increase economic opportunity for the nation's diverse family farmers, farm and food workers, rural and urban communities, and Indian Tribes, and also mitigate the disasters affecting farmers across the country and protect the environment.

Scores of groups, including the undersigned organizations, strongly support equity, justice, and access across the titles of the Farm Bill. We pledge to work with Congress to pass a Farm Bill package that assures producers and communities around the country, who depend on critical programs currently left stranded or which have had funding cut in past Farm Bill proposals and extensions, are afforded the investments needed in rural and urban communities across the nation.

These critical programs, representing a small fraction of overall Farm Bill investments, support assistance for Socially Disadvantaged and Veteran Farmers and Ranchers, Beginning Farmer Development, Rural Development, Renewable Energy, Specialty Crop, Organic and Urban Agriculture, Tribal Relations, Community Food Projects, SNAP Ed and Farmers' Markets. With a frame of equity, we also urge inclusion of support to mitigate widespread disasters, protect natural resources, construct a new and economically viable future for agriculture and rural communities,

and assure access to healthy food economies for all, in urban and rural areas.

Completion of a full and intact Farm Bill in 2013 is critical to the health of our recovering national economy. As Congress moves forward on this important legislation, we urge the members to make all funding and policy recommendations relative to Farm Bill programs with an eye toward the future. We also strongly urge Congress to assure access to affordable healthy and nutritious food for all; continue support for the next generations of our nation's farmers and ranchers; farmland and environmental protection; and ensure the success of our nation's diverse producers, including minority veterans, women, tribal, and limited resource farmers, farm and food workers, and communities most often in greatest need of those important landmark programs created by Congress in the 2002 and 2008 Farm Bill processes.
